3. USE OF PERSONAL DATA AND PURPOSES

We require and use your personal data in compliance with applicable laws for the following reasons, notwithstanding the points mentioned above:

4. HOW WE COLLECT DATA

We employ various methods to collect and process data, including;

i. Information you provide: Data you consent to provide when using our Services or correspond with us;

iii. Information from Third- Parties: Personal data received from third parties and publicly available sources, including analytics for advertising and user analytics purposes.

iv. it is a case of special circumstances such as compliance with court orders, requests/order, notices from legal authorities or law enforcement agencies compel us to make such disclosure;

v. it forms part of the information we share with marketers and advertisers;
